| 4. | Update on election Guidelines and Chapter Bylaws | 1. Shyam Bhavsar explained changes to the Election Guidelines and Chapter Bylaws. The changes were proposed to - align as per RDS - provide flexibility in operations - simplify board positions - thereby creating opportunity for more members to participate Key changes were: a. Elections will be for generic board positions. Board positions would be decided by the board during the first Board meeting after the election. b. From current 10 board positions, it was proposed that there would be minimum 7 and a max of 11 board positions (depending on the governance need of the board) c. Three portfolio names were changed: VP | Updated Chapter Bylaws and Election Guidelines were made available to members before the AGM. All changes were discussed, agreed and approved unanimously by all members present. |
| 5. | Financial summary of chapter | Shyam Bhavsar presented the financial summary and balance sheet with profit and loss as on 31 st Dec.
