**IMPORTANT :**

- 1) Candidate **MUST** be PMI Member (paid \$119) & PMI Pune-Deccan India Chapter member (paid \$10) in good standing.
- 2) One candidate can send nomination for one position only. After deadline for filing nominations is over, nominee cannot change the application for a different post. But an option would be provided to withdraw the nomination, if desired.
- 3) After deadline for filing nominations are over, if nomination(s) not received for certain position(s) then current BODs would decide who would take care of the position(s) from current or elected officers as an additional portfolio to manage.
- 4) Acceptance of nomination is of sole discretion of nomination committee.

If you want to nominate someone else for a board position, send us their name & contact details **latest by Sunday, 7<sup>th</sup> March 2010 - 7.00 PM IST** and nomination team will contact them for the Candidate's Biography Form and resume information. Candidate **MUST** be PMI Member (paid \$119) & PMI Pune-Deccan India Chapter member (paid \$10) in good standing.
